All transactions are securely processed by certified third-party payment providers. We do not store your payment information.

Prices include VAT where applicable.

EU-based businesses eligible for **VAT-exempt orders** must contact us prior to ordering with valid company details and VAT ID. Such invoices are handled manually via email.

5. Shipping & Delivery

We ship to all EU countries and select EEA regions including **Norway, Iceland, Liechtenstein, and Switzerland**.

Shipping fees and delivery estimates are shown during checkout. Since all items are custom-made, production times may extend delivery beyond standard retail timelines. Once dispatched, you'll receive a tracking link via email.

6. Returns & Refunds

Because our products are personalized, **we do not accept returns** unless:

- The item is defective
- The wrong item was produced or shipped

Claims must be submitted within **7 days** of delivery and include a description and photos of the issue.

Approved refunds will be processed to your original payment method within **14 days**.
